# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to revidapp.com and Syntax Error LLC. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Syntax Error LLC. include revid-app.com and ReVid. The ReVid website is a Digital Entertainment site. By using the ReVid website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, ReVid may collect personally identifiable information, such as your:

#### - E-mail Address

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through ReVid's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. ## **Sharing Information with Third Parties**

# **Tracking User Behavior**
